#### **EXECUTIVE SUMMARY:**

The George S. and Dolores Doré Eccles Theater (Eccles Theater) opened in October, 2016. The project was developed by the Community Reinvestment Agency as part of a joint venture with Salt Lake City and Salt Lake County. The 2,500-seat Delta Performance Hall hosts the “Broadway at the Eccles” series and the “Live! at the Eccles” popular event series. The Regent Street Black Box hosts resident groups and local performances of dance, theater, film, and concerts. The venue is managed by Salt Lake County’s Arts & Culture Division which also manages Abravanel Hall, Capitol Theater, Mid-Valley Performing Arts Center, and the Rose Wagner Performing Arts Center.
