<p>In 2021, the Utah State Legislature allocated one-time funding for the Utah Office of Outdoor Recreation to provide a program pursuant to which eligible entities could apply for funding for the acquisition of real estate that would allow for the continuation of the Bonneville Shoreline Trail, or for the construction of projects that provide public access, or to complete sections of the Bonneville Shoreline Trail. The City applied for and received a grant to purchase approximately 32 acres. The funds are to be used specifically for the property purchase. This property will facilitate the future construction of trailhead facilities. In addition, having this property will assure a critical Bonneville Shoreline Trail connection and alignment and will provide better access to other trails in the area that are currently somewhat inaccessible.</p> <p>A public hearing was held on May 20, 2025.</p>
