GRANT DETAILS:

The Salt Lake City Prosecutor's Office has requested funds to support three Victim Advocates. One advocate is currently VOCA grant funded. The request continues their employment. The personnel request is also for two victim advocates. Currently the Prosecutor Victim Service has one advocate to serve victims of Domestic Violence. They can serve approximately one-third of the victims. Two additional advocates would dramatically increase the Prosecutor's Office capacity to serve victims.

The Prosecutor Victim Services will contract with a LCSW to conduct workshops for mental and behavioral health concerns.

The funding request includes a software license for Victim Services Tracking (VSTracking). The City victim advocate has been entering data and information using the county's software license for the tracking system, Victim Services Tracking. The county has discontinued using this program.

The VOCA grant request funds for training, travel, information packet for victims, workshop materials, and emergency services funds.
